

KEMPS HEADED NORTH SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. MAKING A PURCHASE WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The Kemps Headed North Sweepstakes (“Sweepstakes”) is sponsored by: DFA Dairy Brands Corporate, LLC, 8401 North Central Expressway, Suite 400, Dallas, Texas, 75225 (“Sponsor”), and is administered by Twelve Thirty, LLC (“Administrator”) for Kemps, LLC (“Brand”).

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins at or about 12:00 PM (noon) Eastern Time (“ET”) on April 6, 2026 and ends at 11:59:59 PM ET on May 17, 2026 (“Sweepstakes Period”). The Administrator’s computer is the Sweepstakes’ official clock.
2. **ELIGIBILITY:** This Sweepstakes is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees, officers and directors of Sponsor, Administrator, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, representatives, advertising, promotion and production agencies or agents (collectively, the “Sweepstakes Entities”) as well as their immediate family members (defined as including spouse; biological, adoptive, and/or step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) and persons living in the same household (whether related or not) of any of the above are not eligible to enter or win. Void where prohibited by law. All federal, state, and local laws apply.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor and Administrator’s decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical address or e-mail address on a submitted registration. 3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, eligible entrants must visit KempsHeadedNorth.com (“Website”) and enter their valid e-mail address. The entrant must then complete and submit the registration form with all required information, which may include, but may not be limited to, complete first and last name (no initials), street address (no P.O. Boxes will be allowed), city, state, ZIP Code, phone number, and date of birth. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes.

LIMIT: There is a limit of one (1) Sweepstakes entry per person/email address per day. If more than one (1) entry per day is received from the same person, telephone number, or e-mail address, only the first entry received may be considered valid. For purposes of this Sweepstakes, a “day” is the twenty-four (24) hour period between 12:00 AM ET and 11:59:59 PM ET, except on April 6, 2026, when a “day” starts at 12:00 PM ET and ends at 11:59:59 PM ET. Each entrant must submit an entry on his/her/their own behalf. Any entry submitted

on behalf of another individual or using another person’s email address, name, or mobile phone number will be disqualified and ineligible to claim any prize. Any attempt by any entrant to obtain more than one (1) entry per day using multiple e-mail addresses, identities, or any other methods will void such entries, and that entrant may be disqualified. No mechanically-reproduced or automated entries permitted. Use of any automated system to participate is prohibited and will result in disqualification and all such entries will be deemed void. All entries become the property of the Sponsor and will not be returned.

4. RANDOM DRAWING: On or about May 18th, 2026, the Administrator will randomly select one (1) potential Grand Prize winner, two (2) potential First Prize winners, forty-five (45) potential Second Prize winners, sixty (60) potential Third Prize winners, fifty (50) potential Fourth Prize winners, fifty (50) potential Fifth Prize winners, and one hundred (100) potential Sixth Prize winners, from among all eligible entries received during the Sweepstakes Period (“Random Drawing”). Each winner is considered a potential winner pending verification of their eligibility and compliance with the Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

- F. Fifth Prizes (50):** Each “Fifth Prize” consists of one (1) \$25 Cabela’s Gift Card*. The ARV of each Fifth Prize is \$25. No more than fifty (50) Fifth Prizes will be available in the Sweepstakes. The total ARV of all Fifth Prizes is \$1,250.
- G. Sixth Prizes (100):** Each “Sixth Prize” consists of one (1) Kemps Branded Ice Cream Scooper. The ARV of each Sixth Prize is \$10. No more than one hundred (100) Sixth Prizes will be available in the Sweepstakes. The total ARV of all Sixth Prizes is \$1,000.

The Grand Prize, First Prizes, Second Prizes, Third Prizes, Fourth Prizes, Fifth Prizes, and Sixth Prizes are collectively referred to herein as the “Prize(s).”

- H.
